**ORDER OF JUSTICE WAYNE MARTIN**

---

**UPON** the companies in Annex 1 (the “**Companies**”) being placed into administration on 27 September 2020 by the Abu Dhabi Global Market Court of First Instance (the “**ADGM Administrations**”) by the order of Justice Sir Andrew Smith sitting as a Judge of the ADGM Court (the “**ADGM Administration Order**”)

**AND UPON** the application by filed Richard Fleming and Benjamin Cairns of Alvarez & Marsal as administrators of the Companies (the “**Joint Administrators**”), of 3412ResCowork06 and 3412ResCowork05, Regus ADGM Square, Maryah Island, Al Maqam Tower, 34th & 35th Floor, PO. Box 35665, Abu Dhabi, United Arab Emirates, for: (1) recognition of their appointment as administrators duly appointed under the law of the place of incorporation of the Companies and for the active assistance of the DIFC Courts, in particular, to stay proceedings against the Companies in the DIFC Courts; and /or (2) enforcement of the ADGM Administration Order pursuant to Rule 45.8 of the Rules of the Dubai International Financial Centre Courts 2014 (**RDC 2014**)

**AND UPON** reading the signed evidence of Benjamin Thom Cairns dated 20 October 2020

**AND UPON** hearing Mr Adam Al-Attar for the Companies, and no other persons being represented or appearing at the hearing before Justice Wayne Martin on 10 November 2020

**AND UPON** the Joint Administrators undertaking to make a copy of this Order publicly available, including by publication on the website of NMC Healthcare LTD (**Order Publication**)

**IT IS HEREBY ORDERED THAT:**

1. The Joint Administrators of the Companies shall be recognised as such within the DIFC, in particular, as duly appointed agents for each of the Companies entitled to exercise all powers conferred on them as agent, including, among other things, to direct the Companies in litigation in the DIFC Courts.
2. The Joint Administrators shall be entitled to the active assistance of the DIFC Courts in carrying out their functions as administrators, and, in particular, without limitation, the Joint Administrators shall be entitled to apply, or to cause the Companies, to apply to the DIFC Courts to stay any proceedings that have been or may in the future be commenced against the Companies.
3. Pursuant to Rule 45.8 of the RDC 2014, the ADGM Administration Order and all the terms stated in that order shall be capable of enforcement as a non-money judgment upon the application of the Joint Administrators to the DIFC Courts.
4. Any person affected by this Order shall have for 28 days from the date of Order Publication, liberty to apply on five (5) clear days' written notice to the Joint Administrators to set aside this Order. Any such application shall be regarded as a hearing de novo on the issues raised at the hearing of the application for this Order.
5. This Order shall take effect from 11:30am on 10 November 2020.
