As announced on 24 January 2020 (RNS Number: 8388A), Mr Saeed Mohamed Butti Mohamed Khalfan Al Qebaisi sold 813,850 shares and Infinite Investments LLC sold 1,350,000 shares in NMC Health plc on 28 January 2020.
