This is a corrective filing being submitted and replaces the notification dated 13 January 2020 in relation to change in voting rights of Mr. Khaleefa Butti Omair Yousif Ahmed Al Muhairi. This notification consolidates 50% of the shareholding of Infinite Investments, LLC (“**Infinite**”) with the direct and indirect shareholding of Mr. Khaleefa Butti Omair Yousif Ahmed Al Muhairi.

Infinite is a company jointly owned and controlled by Mr Saeed Mohamed Butti Mohamed Khalfan Al Qebaisi and Mr. Khaleefa Butti Omair Yousif Ahmed Al Muhairi. Infinite is a direct shareholder in NMC Health plc and owns approximately 7% shares in NMC Health plc, as disclosed in the announcement dated 8 January 2020 (RNS Number: 1148Z).
